The AMA style is used in the field of medicine and other related fields such as public health. The in-text citations are numbered superscripts that correlate with the numbered references in the bibliography that appear in the order that they are cited. At present, the manual is in its 10th edition (2007).

AMA (American Medical Association) - Citation Styles ...

AMA was developed by the American Medical Association for the purpose of writing medical research. References are found at the end of a manuscript and are titled "Reference List," and each item should be listed in numerical order (two references should not be combined under a single reference number) as opposed to alphabetically.

Citing sources within your paper. Unlike APA or MLA, you will not use the author's last name for the in-text citations. Instead, you will number each instance when you are referencing an article. The order of numbering will be contingent on the order in which you use that reference within your paper.

Citation and style manuals The style recommended by the American Medical Association (AMA) is often used for scholarly writing about medicine or health-related topics, or about other subjects in the sciences. In the AMA style, references to a work or parts of a work inside the text of a paper take the form of numbered citations.

At a minimum, all presentations should include a reference slide at the end AMA formatted citations (may or may not be numbered).
